

This document contains key information you should know about the Excel High Income Fund (the "Fund"). You can find more details in the Fund's simplified prospectus. **Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.**

On September 7, 2017, Excel Funds Management Inc. announced that it has entered into an agreement with Sun Life Global Investments (Canada) Inc. ("Sun Life") pursuant to which Sun Life will acquire all of the outstanding shares of Excel Funds Management Inc. and Excel Investment Counsel Inc. Immediately upon completion of the acquisition, which is scheduled to close by the end of the fourth quarter of 2017, Sun Life will acquire control of the investment fund manager and portfolio adviser of the Fund. The proposed change of control of the manager of the Fund is subject to receipt of all required regulatory and securityholder approvals, as well as satisfying the conditions of closing.

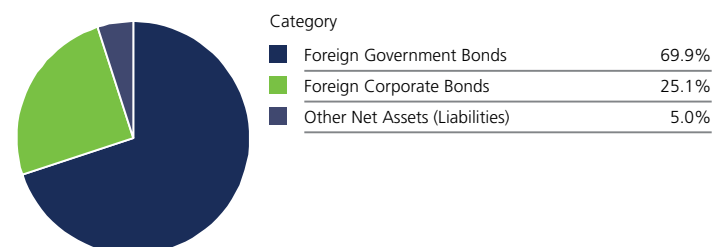

### How risky is it?

The value of the Fund can go down as well as up. You could lose money.

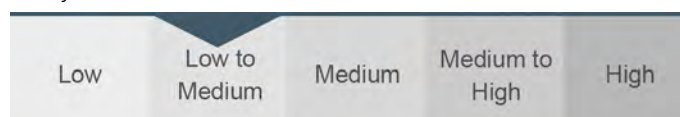
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

Excel has rated the volatility of this Fund as low to medium.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

### No guarantees

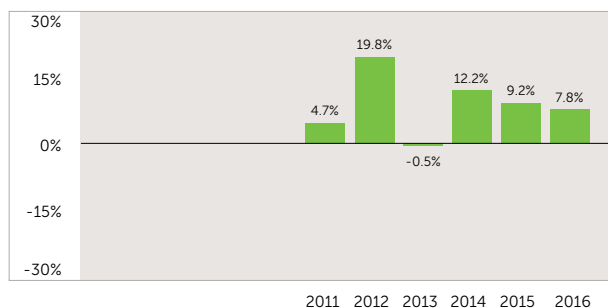
Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

## How has the Fund performed?

This section tells you how Series F units of the Fund have performed over the past 6 years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

### Year-by-year returns

This chart shows how Series F units of the Fund performed in each of the past 6 years. This series of the Fund has dropped in value in 1 of the 6 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for the Series F units of the Fund in a 3-month period over the past 6 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### Average return

The annual compounded return of Series F units of the Fund was 7.8% since inception. If you had invested \$1,000 in this series of the Fund at inception, your investment would now be worth \$1,669.

### Who is this Fund for?

The Fund may be suitable for medium-term investors who:

- want exposure to emerging market debt securities with a focus on government-issued debt; and
- are willing to accept a low to medium level of investment risk.

### A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

### How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series F units of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

#### 1. Sales charge

No sales charges apply when you buy or sell Series F units of the Fund. Instead you pay a fee directly to your representative's firm under its "fee-for-service" or "wrap account" program.

#### 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns. As of March 31, 2017, Series F expenses were 1.63% of the value of Series F. This equals \$16.30 for every \$1,000 invested.

### More about the trailing commission

Excel does not pay a trailing commission to your representative on Series F units of the Fund.

### 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What you pay
<b>Registered Plan Fee</b>	An annual administration fee of \$20 may be deducted automatically from a registered plan if not paid directly to Excel.
<b>Short-term trading fee</b>	2% of the value of units you sell or switch within 30 days of buying or switching them. This fee goes to the Fund.
<b>Switch fee</b>	You can switch all or some of your units of one Fund to units of another Fund offered by Excel if applicable minimum investment requirements are met and you meet the eligibility criteria for such series. Before switching any Series F units to Series A units, unitholders will be required to choose a purchase option and pay the fees and charges associated with that purchase option. If you do not choose a purchase option, you will be automatically deemed to have chosen the Initial Sales Charge Option. Your representative's firm may charge you up to 2% of the value of your units when you switch them to another Excel fund.

### What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
